Notice of Intention to Issue a Development Variance Permit (Application No. DVP01265 – 3137 Hawthorne Place)

The Council of the Resort Municipality will consider a resolution to issue a Development Variance Permit under s. 498 of the *Local Government Act* at its regular meeting to be held at:

Time: 5:30 p.m., **Tuesday, March 25, 2025**

Location: Franz Wilhelmsen Theatre at Maury Young Arts Centre

4335 Blackcomb Way, Whistler, B.C.

The land that is the subject of the Permit is legally described as: PID: 004-551-214, LOT 13 BLOCK J DISTRICT LOT 4750 PLAN 17377, as shown on the map attached to this notice.

The purpose of the Permit is to vary Whistler's Zoning and Parking Bylaw 303, 2015 to vary the rear setback to accommodate two existing stacked decks on permanent foundation support posts located 5.25 metres from the rear (southwest) parcel line and to vary the rear setback to accommodate an existing post with an exposed footing located 5.0 metres from the rear (southwest) parcel line.

Without the proposed variances decks on permanent foundation support posts are not permitted to be located within 7.6 metres of a rear parcel line and deck support posts are not permitted to be located within 7.6 metres of a rear parcel line.
